Ontario is implementing a new regulatory framework in 2021 that makes each producer responsible for the collection and management of their used antifreeze and antifreeze containers, oil filters and empty oil containers.

PREPARING FOR CHANGE

The province's new approach to managing Municipal Hazardous or Special Waste (MHSW), including automotive materials, began in 2016 with the introduction of the **Resource Recovery and Circular Economy Act.**

Instead of collective responsibility under a program plan, such as the one operated by AMS since 2017, the Act introduces the principle of **individual producer responsibility** (IPR) for materials. Regulation replaces program plans.

IPR creates a **new legal obligation** for producers that differs from the current collective obligation.

Regulatory transition was initiated in August 2019 with the Minister of the Environment and Climate Change directing the **wind up of the MHSW Program** by September 30, 2021.

AMS is completing its review of the Hazardous and Special Products (HSP) Regulation issued in early June and finalizing its PRO service offering.

DELIVERING RESULTS

A key feature of the new regulatory framework is **providing producers with options** for meeting their recycling obligations.

Producers can establish their own recycling system or they can **join a Producer Responsibility Organization (PRO)** like AMS to carry out their regulatory responsibilities.

As a trusted and experienced recycling service provider, AMS will be the PRO that offers producers a **smooth transition and continued compliance** under the new regulation.

Producers joining the AMS PRO will immediately benefit from our proven and secure reporting system and extensive reverse supply chain experience that will enable environmental performance.

With AMS, producers can continue to rely on informed support from our Steward Services team throughout the transition process.
